#### **0. PREAMBLE**

The purpose of this License is to make a manual, textbook, or other functional and useful document "free" in the sense of freedom: to assure everyone the effective freedom to copy and redistribute it, with or without modifying it, either commercially or noncommercially. Secondarily, this License preserves for the author and publisher a way to get credit for their work, while not being considered responsible for modifications made by others.

#### **1. APPLICABILITY AND DEFINITIONS**

### **Chapter 1. Politics**

The most important thing for political regime of USIP <sup>[1]</sup> is to prevent ethnic conflicts. Various mechanisms for preventing conflicts are needed.

#### President

The president is the head of state. The president is elected directly by the people. The president is commanderin-chief.

## **Separation of powers**

The executive, the legislature and the judiciary are under the doctrine of the separation of powers.

# Bicameralism

The legislature is composed of two houses. The lower house's choice overrides the upper house's selection under the Constitution.

## **Prime minister**

The prime minister is chosen from the lower house. The prime minister selects ministers of the cabinet.

### **Peacemaking committee**

Peacemaking committee resolves ethnic conflicts through dialogue. Peacemaking committee members are chosen from the upper house. Peacemaking committee is a advisory organization to the president. The president follows their advice to maintain peace.

#### The state government

The state governments prevent ethnic conflicts by local autonomy.

Jerusalem is the capital. The capital and the state governors are chosen in each election. The governors have their own police power.

### **E-democracy**

Once <u>Yoshimune Tokugawa</u> established the petition box (meyasubako in Japanese) to adopt folk wisdom. Nowadays, we can create website with <u>internet forum</u>, <u>wiki</u>, etc in order to establish <u>e-democracy</u>.

## Chapter 2. Law

Prevention should be valued more than punishment.

### Constitution

The constitution need to be established under the Universal Declaration of Human Rights (UDHR).

# **Criminal code**

Nobody shall be put ethnic-group name in every identification cards. No person shall do derogatory public statement with ethnic slurs.

Unauthorized possession of weapons is prohibited.

### Earthquake and tsunami

Once upon a time Moses crossed the Reed Sea. There is the ebb before tsunami as is well known.

The building standards act is enacted including quake-resistance standards. The federal government prepares the system of <u>earthquake early warning</u> and the tsunami warning system in accordance to the law. The state government builds embankments and tsunami evacuation towers.

### **Chapter 3. Repatriation and settlement colony**

The government should select the residence of Palestinian refugees from the viewpoint of multiculturalism.

### Repatriation

The federal government restores the lands to Palestinian owners as wide as possible. The government prepares the settlement colony to Palestinian refugees in the event that is impossible. Israeli move to the settlement colony from West Bank areas with the exception of the moderates. Meanwhile, the government must respect the rights of Bedouin.

#### **Settlement colony**

The federal government and private-sector corporations establish the joint venture (JV) under <u>PPP/PFI</u> mode to develop arid land as settlement colony. The JV introduces desalination plant to irrigation system. The JV invites arid land researchers and drip irrigation experts at the same time.

Electric power companies generates electric power from <u>renewable energy</u> as much as possible. To make up for an electric power shortage, electric power companies and gas companies also builds natural gas power stations. <u>Power to gas</u> is the best technology to store the excess power such as hydrogen <sup>[2]</sup> and methane. So electric power companies need to form a business tie-up with gas companies.

The joint venture attracts agricultural corporations, food companies and carrier business. The JV also plants cedrus libani for the purpose of desert greening. The state government builds infrastructure and public facilities.

The JV needs to make plans according to precedent of the Valley of Peace initiative.

### **Separation barriers**

The federal government breaks down separation barriers and develops buffer zones such as settlement colony and industrial parks.

## **Chapter 4. Industrial promotion**

Industrial promotion is very important because the repatriation causes rapid population growth.

#### **Economic Community**

<u>The Middle East Economic Community</u> need to be established by Middle East countries including USIP. USIP needs to join the Union for the Mediterranean.

### **Superconducting Maglev**

The federal government, neighboring countries and investors establish a international railway company for the SCMaglev (Superconducting Maglev) from Egypt to Turkey after the end of Syrian civil war. Power stations are vital for maintaining this machine. The company also install optical fiber cable side by side with the track. The company receives investment from private banks, Official Development Assistance (ODA) and the World Bank.

### Transportation

Infrastructure improvements such as roads, controlled-access highway, railways, Shinkansen (Japanese high-speed railway) and airports are needed.

# University

The federal government establishes the university of agriculture to develop arid land and the institute of technology in an attempt to promote industrial parks.

#### Loan

Financial authorities promote <u>venture capital</u>, <u>micro credit</u> and <u>crowdfunding</u>.

# IT industry

The government promotes open source to cultivate the information technology industry.

#### Gaza recovery

The Gaza government builds extra condominium buildings to recoup part of the cost. The Gaza government rebuilds infrastructure including water supply and sewerage systems, roads, electric generation plant, gas supply and peace memorial park by utilizing the private finance initiative (PFI).
